> Haakon School District 27-1 Board of Education Meeting Minutes July 10, 2017

The Board of Education of the Haakon School District 27-1 met in session for its annual meeting on July 10, 2017 at 7:00 p.m. at the Philip Armory, Room A-3. Business Manager Britni Ross called the meeting to order with the following members present: Doug Thorson, Vonda Hamill, Anita Peterson, Mark Radway, Scott Brech, Jake Fitzgerald, and Brad Kuchenbecker. Also present: Superintendent Jeff Rieckman, Secondary Principal Mandie Menzel, Business Manager Britni Ross, Lisa Schofield, and Nancy Haigh.

The meeting was opened with the Pledge of Allegiance.

All action taken in the following minutes was by unanimous vote unless otherwise specified.

- 18-01 Communications from the audience: None
- 18-02 Motion by Brech, second by Thorson to approve the agenda as presented.
- 18-03 Business Manager Britni Ross administered the oath of office to elected members Scott Brech,Vonda Hamill, and Anita Peterson (all 3 year terms).
- 18-04 Business Manager Britni Ross conducted the reorganization of the Board for FY 2017-2018. Brech nominated Mark Radway for President of the Board of Education; Kuchenbecker nominated Jake Fitzgerald for President. Motion by Hamill, second by Peterson that nominations cease. After a ballot was cast, Radway was declared the President by a 4-3 vote. Radway assumed the chair. Peterson nominated Fitzgerald for Vice President of the Board of Education. Motion by Thorson, second by Peterson that nominations cease. After a motion duly made, seconded, and carried unanimously, Fitzgerald was declared Vice President.

BHSSC Representatives Peterson and Thorson (Alternate) : There is a \$74 stipend paid for attending each BHSSC meeting. The board sees no conflict in these appointments. Motion to approve appointments by Hamill, seconded by Fitzgerald.
- 18-08 Motion by Thorson, second by Peterson to name Vonda Hamill as the Delegate to the Delegate Assembly of the ASBSD, with Brad Kuchenbecker as the alternate.
- 18-09 Danny Wegner, CMAR gave a building project update. The project is still running on time, even though a few days were lost to rain. The masons are on side and will start assembling walls. Some plumbing has begun. There have been no unforeseen issues to date, and things are running smoothly.
- 18-10 Motion by Brech, second by Hamill to approve Alternate Bid 3 for demolition of the 2-story primary building. The bids are from Lind Exco for demolition in the amount of \$28,838 and Muth Electric for unhooking electricity in the amount of \$1588.00.
- 18-11 Motion by Fitzgerald, second by Peterson to approve publishing the list of employee contracts per SDCL 6-1-10.
- 18-12 Motion by Hamill, second by Thorson to approve the barium chloride bid received from Finoric, LLC in the amount of \$1.25/lb delivered for 8816 pounds. This amount is the same as last year's barium cost. This was the only bid received.

- 18-13 Motion by Hamill, second by Thorson to approve a bid received from Hanson Oil in the amount of \$1600.00 for a double-wall fuel oil tank. This was the only bid received.
- 18-14 Motion by Peterson, second by Fitzgerald to approve the following personnel action: Barb Bowen, second half of summer school \$2000.00. She was previously approved for one half, but will now be teaching both sections.
- 18-15 Heard the second reading of Policy AH: Conflict of Interest Disclosure and Authorization.
- 18-16 Heard the second reading of Policy AH-E (1): Conflict of Interest Disclosure.
- 18-17 Heard the second reading of Policy AH-E (2): School Board Action on Conflict of Interest Disclosure of a Direct Benefit.
- 18-18 Motion by Thorson, second by Kuchenbecker to approve emergency adoption of Policy EF: Food Services Management. New USA requirements mandate that we have this policy in place immediately and available to mail to all households before school begins in the fall.
- 18-19 Budget Hearing Published budgets were reviewed. No changes at this time were made to the proposed budgets reviewed in May.
- 18-20 Motion by Thorson, second by Hamill to enter into executive session at 7:43pm for personnel matters per SDCL 1-25-2(1). Motion by Fitzgerald, second by Hamill to resume meeting at 7:54pm.
- 18-21 Anita Peterson gave the BHSSC report.
- 18-22 High School Principal Mandie Menzel reported on the following items: (A) The large scoreboard at the football field was destroyed in a storm on June 28th. The greenhouse also sustained some damage. Insurance claims have been filed. Some families who had previously donated to the cost of the old scoreboard would like to donate again. (B) Congratulations to Dylan Schofield, the only PHS student to qualify for the National High School Rodeo Finals. Dylan will compete in bronc riding. (C) Eric Eisenbraun with GoldenWest is preparing a quote for the maintenance of servers and security cameras. (D) A conflict in scheduling between the SD 4-H Rodeo Finals and SDHSAA has led to some discussion over when the first football games of the season will be played. There is

a very good chance that the solution will be playing the first football game on a Thursday night rather than a Friday night to give 4-H rodeo qualifiers a chance to participate in both.

18-23 Superintendent Jeff Rieckman reported on the following items: (A) Thank you to the Board of Education for having us come back to Philip. Lori and I are happy to be here. (B) The new scoreboard has been ordered and should be shipped around August 10th. The poles will be replaced with steel beams. (C) Mike West, on behalf of Gaylord Paulson, visited with Jeff and Britni about Gaylord doing a mosaic scottie dog for a wall somewhere in the school. The architects have confirmed that the east wall of the new lunchroom/commons would be a good place for something like that. We would like to give Gaylord our blessing to proceed and thank him for his generosity.
(D) Auditors will be here July 18th -20th. (E) Jeff will attend the Superintendent's Conference in Chamberlain on July 17th-19th. (F) The joint ASBSD conference is coming up in August - please let Lisa know if attending so she can send in registrations.
