16-99 Toby Morris, with Dougherty & Associates and Tim Cheever, with Upper Deck Architecture met with the board to discuss the financial and architectural aspects of the proposed new building project. The approximate cost of the project is \$10 million . With some cash on hand and issuing capital outlay certificates, the cost of the project could be secured with current revenues levied as is. It is vitally important to note that this project will not cost the taxpayer any additional tax over what they are currently paying. Also important to note is the new building would bring all students under one roof, and the facility can be secured during the day, with only one access for visitors. If this project does not come to fruition, the board will consider reverting to the renovation plan provided by Upper Deck late last fall. The estimated cost of that project would be in the \$6 million range. Tim Cheever provided updated building plans for the board and meeting attendees to look at.

We will continue with the research/planning and will look into possible dates in February or March for another special meeting and public hearing to consider the building resolution. Preliminary building plans are posted for viewing in the Business Office.
